



Klub Member's Agreement

I, _____, hereby certify that my dog(s) _____ is/are in good health, has/have not previously harmed or shown aggressive or threatening behavior towards any person or any other dog. I have also read and agree to the following:

1. I understand that Key's Kanine Kountry Klub is an open-play environment and because of this there are inherent risks, which even closely monitored, may result in the following:
 - a. Behavioral problems.
 - b. Injuries such as sore pads, abrasions and cuts, broken nails, puncture wounds.
 - c. Transfer of communicable illnesses such as, but not limited to, respiratory illnesses, including kennel cough, canine papilloma and/or parasites.
 - d. Skin or eye irritation due to grooming services or cutting a nail quick.
2. If health or behavioral problems develop with my dog(s), that these will be treated as deemed best by the staff of Key's Kanine Kountry Klub within their sole discretion, and I assume full financial responsibility for any and all expenses involved.
3. Key's Kanine Kountry Klub and their staff will not be liable for any health or behavioral problems that develop in my dog(s), and I hereby release them of any liability of any kind whatsoever arising from my dog(s) attendance and participation at Key's Kanine Kountry Klub.
4. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Key's Kanine Kountry Klub, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the Owner. The owner agrees to be solely responsible for the payment of all medical bills for of your dog and you release, and hold harmless the following:
Key's Kanine Kountry Klub, it's officers employees of and from any and all responsibility for, or claims, damages, or debts arising out of or related to such medical care, including but not limited to, transportation to/from the veterinarian clinic and choice of veterinarian or animal hospital.
Key's Kanine Kountry Klub also has the right to obtain medical information from my veterinary clinic in regard to my dog(s) as needed.
5. I agree to maintain regular flea, tick and heartworm preventative maintenance programs for as long as my dog(s) has/have active attendance and participation at Key's Kanine Kountry Klub.
Owner further agrees to provide proof of preventative flea/tick treatment program and to be financially responsible for any required treatment for flea/ticks, if determined necessary by Key's Kanine Kountry Klub.
6. I am solely responsible for any harm, including to any other dog(s), to the employees or invitees of Key's Kanine Kountry Klub or to the equipment, facilities or other property of Key's Kanine Kountry Klub, caused by my dog(s) while my dog(s) is/are attending Key's Kanine Kountry Klub.
In the event my dog causes injury to another dog or to a person while at Key's Kanine Kountry Klub, I agree to indemnify and subrogate Key's Kanine Kountry Klub and their employees from any action that may be brought against them, and for any defense settlement or judgment against them. I assume liability for the actions of my dog(s).

7. I agree to not file legal charges demands or claims against Key's Kanine Kountry Klub and its employees for any injury, death or loss of my dog. I hereby waive and release Key's Kanine Kountry Klub from any all liability for any nature for any injury, death or loss of my dog resulting from their actions while in the custody of, or on the grounds or surrounding area of Key's Kanine Kountry Klub. I understand the concept of day/overnight stay is to allow the dogs to be socialized by interacting with people and other dogs. I assume all risk of injury to my dog while at Key's Kanine Kountry Klub or in transporting to any veterinary clinic
8. Owner specifically represents to Key's Kanine Kountry Klub that, to Owner's knowledge, the pet has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this Agreement, Owner also agrees to notify Key's Kanine Kountry Klub of any known exposure of pet to a communicable disease and hold pet out of attending until pet is symptom-free for a minimum of 30 days or with written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by Key's Kanine Kountry Klub policy.
9. If I ask to place more than one of my dogs in the same kennel for boarding, I assume liability for any injuries they cause to each other.
10. Key's Kanine Kountry Klub has the right to refuse service as deemed necessary by the owner and/or staff of Key's Kanine Kountry Klub at any time including, but not limited to, my dog(s) demonstrating aggressive behavior toward other dog(s) or people or injuring another dog(s) or person(s).
11. Photographs and other graphic, sound, or other image, likeness, recording, etc. may be made of my dog(s) by Key's Kanine Kountry Klub and that such may be used for any purpose without compensation, and I release to Key's Kanine Kountry Klub all rights that I may possess or claim to such image, likeness, recording, etc.
12. Owner specifically represents that he or she is the sole Owner of the pet, free and clear of all liens and encumbrances.
13. All charges associated with the stay of my dog(s) at Key's Kanine Kountry Klub including, but not limited to, daycare, boarding, grooming and/or any veterinary or liability charges will be included in my invoice.
14. Payment is expected when services are rendered for daycare, For boarding, a non-refundable deposit of \$50.00 per dog is expected within five (5) days of booking to hold reservations and balance paid at the end of the boarding stay. I understand my dog(s) will not leave the premises until all charges are paid in full. Additional boarding fees will be applied. Should you wish to pick up your dog(s) early, you may do so, however you will be required to pay for the entire boarding reservation (original days booked).

I have received, read, understand and agree to the terms outlined in this Agreement. I understand that all terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Key's Kanine Kountry Klub. I also understand this is a legally binding contract.
